PT/OT Skilled Therapeutic Exercise Documentation Examples ...

Method: Provider #1 -100 minutes of service time + 80 minutes of documentation time= 180 minutes divided by 10 beneficiaries = 18 minutes billed per beneficiary. . Provider #2 -60 minutes of service time + 70 minutes of documentation time= 130 minutes divided by 10 beneficiaries= 13 minutes billed per beneficiary.
